Byelaws Progress report. Cllr D Payne had met with Clerks. Advice from NALC sought, to be referred back to individual Councils and Rec Ground Committee for comment in due course

Dog Bin/Litter bin issues Problems with SCDC emptying schedules and dog bin still to be relocated from Homefield Park to the Copse. New dog bin to be installed near the Dole following request from Dist Cllr Chatfield. Waterbeach Parish Council suggest employment of a joint Dog Warden for surrounding villages. Not high priority but agreed item for next agenda

6. Budgets

Agreed budgets for 2008-09 supplied. Draft budgets for Years 2 & 3 reviewed

Year 1. Proceed with replacement of seat at The Coppice (QEII Memorial). Highlight replacement in Crier. Chase Andy O/Hanlon on NIAB art. Gatekeepers Hut – agreed to seek sponsorship. Kissing Gate – requested from County Council

Year 2. Increase additional ringfenced funds to £1,200 each year to now include replacement fund for benches

Clarified ringfenced amount after Year 3 would total £3,400

Discussion on sponsorship and donation opportunities for open spaces, benches, etc.

7. Histon Football Club Holdings – possible transfer of The Copse

Report on current situation and various discussions held. Debate on initial reasons for request, costs and risks. Allison Conder had contacted SCDC on TPOs issues. Agreed to ask Allison Conder to work a paper up to go out for costs, if necessary by carrying out survey. Results to go back to Full Council for discussion on whether to proceed with negotiation.

8. Tree Wardens Report

Allison Conder unable to attend meeting Scots Pine at The Coppice (rear of 35) Following request for report, Acacia advise ivy severed (done by Enviro Volunteers) on larger tree, otherwise monitor only Histon Football Club landscaping comment and up-date on-going. Cllr Nudds awaiting clarification from County Council on ownership of land. Histon PCllr Eade had input to plans for landscaping and discussion continued with David Hamilton at SCDC to achieve a quicker growing belt

Commemorative Trees Tree to commemorate Trevor Silk's service, on hold till Autumn. Agreed to ask Allison Conder to put together guidelines for suitable sites for trees. HICCA had asked about planting in Impington

1 The Coppice telephoned complaint on lack of light. Discussion on nature of shading to houses next to wooded areas. Agreed complaints must be in writing

The Copse reports to Police regarding Anti Social Behaviour towards recently installed bird boxes

9. Street Furniture

Seat at The Coppice damaged beyond repair. Reported to Police. Agreed insurance claim not cost-effective. Agreed to replace from Year 1 budget, design and price to be agreed

- Move further back to a site to be identified, but at least in part-sun
- Remove current concrete base
- Look at using slabs beneath new seat
- Ask SCDC if bin can be moved to adjacent to seat

10. Chairman's Report

Cambs County Council had carried out various works including patching; bollards in Butt Lane. Cllr Nudds continued to press for other works to be completed. Damage to verges New Road and Mill Road reported to County Council.

Rights of Way Cllr Nudds delegated to provide ideas for circular walks and other safer routes to Peter Duthie, on behalf of Impington PC

Probation Team Not currently working in Impington. Will return in due course

Gatekeepers Hut Cllr Nudds up-dated on report given to Planning Committee. Idea to re-use old lamp post from Railway Vue site raised. Acknowledged that uses needed careful thought now, and funding to be sought. Ballpark figure of £7,000 to £10,000 mentioned

Clay Close Lane Ditch on-going. Report now received from expert on wildflowerers.

Milk Float purchase. No progress

Daffodil Planting Trevor Silk had taken photos and identified infill areas particularly near Holiday Inn.

Agreed wildflowers also to be provided this November in Coppice, Clay Close Lane and Homefield Park areas

Telephone Box Milton Road had been vandalised. Police aware. Agreed to ask BT for repair

Rospa report provided. Cllr Abdullah to consider and report to Full Council

12. Lorry Parking in Cambridge Road

Response for AJC report. Cllr Kelly had met Richard Preston, as agreed. Report to AJC suggested "blanket" approach for the 2 villages. Joint funding issues debated. Emerging Charter discussed

Matters arising from Minutes 3 September 2007 War Grave, Hunt Commonwealth War Graves Commission had agreed to tidy. Lawn Memorials gardens mostly now returned to grass. Notice now moved to area still not re-instated. Strimmer and new mobile phone purchased Water Supply investigation commenced, agreed to progress as soon as possible

Walkabout date Agreed 5 August 2008 6pm

Review of Fees Suggestions put forward by Clerk following review of other parishes' fees, and also City Council and Church Commissioners. Discussion on finite area of land available and possibilities such as wall plaques for ashes in future. Finally agreed no age differentials to apply, subject to Clerk checking issues surrounding this decision. Grant of Exclusive right of burial to remain at 99 years.
