015.1	Update on County Council position - informal meeting held with Stephen Conrad 21 May, further meeting due 18 June. Notes provided to all. Cllr Jenkins and Cllr Davies met with Stephen Conrad on 18 June. Confirmation County Council intend to proceed with offering a lease on Bypass Farm. Lease length approximately 40 years envisaged. County will send Heads of Terms for proposed lease for Parish to then consider. Valuation will be needed. Tenancy expires end of 2014. Either party to give 3 months recall. Mr Conrad to advise tenant as soon as possible so can be more widely reported. Likely decision to let tenancy expire but preparations in meantime for planning permission, proposals etc. can go ahead. Care of land after proposed lease in place discussed, current farmer of land could be approached to tend to upkeep. Committee to approach Parish Council as soon as have valuation to move forward and consider funding options. Cllr Davies wished to advise residents of Cottenham Road as soon as appropriate Revised General Arrangements Drawings Cllrs Davies and Ing met with PJ Townsend Associates, new plan drawn up following that meeting.
