Cllr Davies, Clerk and Groundsman had met with CC to look at potential replacement nets and possible relocation of entrance from car park to HFC; it was felt this could be an opportunity to replace fence and the committee were asked to note possible increase in cost of proposed project. Once quotes received proposal to be made to Parish Council in June. It should be noted that the existing fence is the property of HFC. ➤ Updated Recreation Ground Development Plan − report copied to all (Appx. 7). Report included suggested improvements to safety surfaces (currently bark chippings) and paths on recreation ground play area and that consideration be given to replacing fence at The Green play area.
