12/215	<b>RESOLUTION: “Further to the decision of Histon &amp; Impington Parish Council at their meeting of 28<sup>th</sup> January 2013 to agree to request precept for 2013-2014 of £263,200 from SCDC, split between the 2 parishes by use of Band D equivalents for 2013-14 of 1484.1 (Impington) and 1736 (Histon), it is further agreed that the Council Tax Rate for Histon Parish be set at £81.87 and that of Impington Parish be set at £81.58”</b> Proposed by Cllrs. Parish, Ing, Payne, Davies and Jenkins  Resolution was read out. Discussion followed on: <ul style="list-style-type: none"> <li>➤ Nature of office error resulting in altered precept elements for Histon and Impington</li> <li>➤ High cost of changing payments to be collected by SCDC, estimated at £10,000 +</li> <li>➤ Notice on website highlighting Parish Precept amounts to be collected</li> <li>➤ Possibilities of changes to ratio in future years, or totally equalising figures</li> </ul> All in favour and <b>agreed</b>
