It further asks the Community Park sub-committee to:

- implement good project management disciplines; and
- · prioritise:
 - o research to determine the community's need and willingness to pay for the facilities that might be implemented at the Milton Road site; and
 - o resolving the outstanding matter of safe access for pedestrians and cyclists.

It further requests that the Council takes a strategic view and initiates work to:

- consider the options arising because of:
 - the Infants School site being vacated; and
 - Bypass Farm being included in the South Cambs Local Plan in policy SC/1 as a site 'allocated to meet local need for open space'.
- determine how best to work with the County Council to deliver open space access at Buxhall Farm;
- develop joint working with the owners of other recreation land in the community in order to maximise access to it and especially to develop a community wide approach to delivering a 3G pitch."

and outlined:

- need to build on motion to bring focus
- need to encourage project team to be more assertive
- changes since signing agreement; Neighbourhood Plan Reg 14 Consultation underway, SCDC Local Plan Adoption; development of School at Buxhall Farm site
- suggestion that Parish Council onsider independent planning consultancy
- Pedestrian and cycle access not yet addressed
- an understanding of how Carter Jonas are going to address planning considerations raised during pre-application process required
- Request sight of content/comment forms at upcoming consultation

Cllr Ing expressed support for the aspirations noted in the amended motion, and underlined the need for the Council to proceed to work together to make best use of this opportunity, pointing out the Sub Committee would be happy to take the comments on board going forward. Cllr Jenkins withdrew the amended motion.
